### President's report.

- 1. Board members were asked to volunteer for committees. Assignments will be made at the Board of Trustees meeting on August 9, 2023.
- 2. The Board President welcomed newly appointed Trustee Frances Anterola to the Board.

#### Secretary's report.

1. Approval of June 13, 2023, Board Meeting minutes. Barbara Levine moved to accept the minutes with a minor correction. Chastity Mays seconded. MOTION passed unanimously.

# Financial report.

- 1. Approval of bills payable up to and including bills due July 16, 2023, to August 15, 2023. The Finance Manager requested to pay the complete amount of \$35,246.10 due to West Bend Mutual Insurance Company for general library insurance instead of making monthly payments. Julian Pei moved. Joyce Hayes seconded. MOTION passed unanimously.

- 3. The Director and Finance Manager would like to add board members to the library's Illinois Funds account for security purposes. The Board President suggested that members of the Finance Committee be added to the account.

# Librarian's report.

- 1. Building and grounds maintenance.
  - a. Trustee Philip Brown expressed concern about the poor condition of Monroe Street. The Director will contact the City to determine whether the street can be repaired.
  - b. The carpet near the restrooms and water fountain was cleaned on Monday, July 3. The library opened two hours late to allow the carpet to dry. The Director reported that the carpet looks better after cleaning but needs replacement in the future due to its condition.
- 2. Illinois Public Library Annual Report (IPLAR).
  - a. Talked about report highlights, including an increased number of active library card accounts and program statistics. The report was submitted to the Illinois State Library before the deadline of June 30, 2023.
- 3. The Director hired a part-time Youth Services Assistant. Teen and Youth Librarian Liz Hartman will transition to a Programming and Outreach Librarian position in August. The Director has begun internally searching for a Teen and Youth Librarian/Coordinator.
- 4. Carbondale Public Library has a newly released app, SHARE Mobile Library, that allows patrons to find books, place holds, and use self-service to check out items.
